GCPHD Monthly Update

### 1. Monthly Situation

#### PHIG


The PHIG grant was fully approved on December 31, confirming that Geary County will receive the entire allocation of \$137,098.57, with no loss of funding. A Budget Modification Request (BMR) was submitted on January 12 to align the grant with updated guidance and reporting requirements. We are currently awaiting KDHE's release of the Financial Status Report (FSR) so the remaining \$43,294.29 for Quarter 4 of 2025 can be processed and reimbursed. At this point, the grant is in good standing, and all required actions on our end have been completed.

#### Influenza Season


Since the end of December, Geary County has experienced a measurable increase in reported influenza activity following relatively low levels earlier in the season, consistent with trends across Kansas and nationally. CDC respiratory surveillance indicates that influenza activity remains elevated nationwide, with influenza A (predominantly H3N2) continuing to circulate and respiratory illness expected to remain elevated for several more weeks. Kansas influenza surveillance systems similarly show increasing influenza-like illness across outpatient and emergency department settings, and regional reporting from the Kansas City metro area reflects a comparable late-December surge. Local Geary County data align with these patterns, indicating increased community transmission and healthcare utilization related to respiratory illness. Public health efforts continue to emphasize vaccination, early treatment for high-risk individuals, and preventive measures to reduce transmission and severe outcomes.




**Acute Respiratory Illness – JAN26: 22.2% - DEC25: 11.2% - JAN25: 19.4%**




**RSV – JAN26: 0.4% - DEC25: 0.0% - JAN25: 1.8%**




COVID-19 – JAN26: 2.9% - DEC25: 1.0% - JAN25: 3.1%

Deductions are categorized into three areas: chargeback claims, partner claims, and hardware fees.

**Chargeback Claims – \$810.05:**

This amount is the result of a billing system issue involving two patients, totaling \$810.05, for whom VaxCare was unable to verify eligibility within their system. These claims will be resubmitted to VaxCare with additional supporting documentation to resolve the discrepancy.

**Partner Claims – \$824.73:**

These charges are billed outside of the VaxCare platform and are reflected within our cash, card, and insurance revenue. The claims have already been submitted for billing and are in process.

**Hardware Fee – \$20.00:**

This represents the monthly fee for use of the VaxCare-provided hub.
